2020 YMCA OPEN ENROLLMENT

The Independent Living Center of North Central Ohio is excited to announce the upcoming open enrollment for the 2020 YMCA Program. Open enrollment will begin October 7th and ends December 3rd. If you are unable to make this deadline you must call to make further arrangements before December 3rd. Please note that there have been changes made to the YMCA policies. You will be required to do the following: complete an intake, fill-out a YMCA program application, bring verification of household income (preferably W2's) and verification of disability (doctor's note) at the time of sign up. Caregivers are only permitted if deemed necessary by a doctor in your verification of disability, or if the consumer is a minor. Guests will be charged the daily rate of \$5 or should obtain their own membership. Please note that this program will be income based. We do intakes from 9am-4pm, Monday thru Friday. Our office is located at 2230 Village Mall Drive, Suite 200 Mansfield, OH 44906. If you have any questions regarding this program, please feel free to call us at 419-526-6770.

UPCOMING 2020 CENSUS

What is the Census?

The U.S. Census Bureau is the federal government's largest statistical agency. They are dedicated to providing current facts and figures about America's people, places, and economy. The U.S. Constitution requires that each decade we take a count of America's population. The census is important to us and our community. It determines how many representatives each state gets in Congress and is used to redraw district boundaries. Communities rely on census statistics to plan for a variety of resident needs including new roads, grant funding, schools, and emergency services. Businesses use census data to determine where to open places to shop. Each year, the federal government distributes hundreds of billions of dollars to states and communities based on Census Bureau data.

How Does the Census Work?

The first step in the census is building a master list of every address in the United States. The Census Bureau is working on this right now using U.S. Postal Service records, satellite imagery, and other government and business records. In 2020, you will get a census notification in the mail. You will be encouraged to fill out the 10-question form online. There will be an option to get a paper form and mail it back or to call the Census Bureau to give your response. The census expects to employ more than 500,000 temporary workers in 2020. The Census Bureau workers will knock on your door to ask you the questions in person if you do not reply via online form, phone, or mail. After knocking on your door, if you are still unable to be reached, a census worker will ask your neighbors or a manager in your apartment building or subdivision how many people live in your house. As a last resort, the Census Bureau will look at any data they have from state or local records about who lives in

- Must be available to fulfill the requirements of a state titleholder. These include travel within your state, travel to the national competition, and numerous public appearances
- Must possess good communication skills
